## **TERMS OF CREDIT**

IN EXCHANGE FOR THE EXTENSION OF CREDIT BY HERITAGE TO APPLICANT, APPLICANT EXPRESSLY AGREES THAT ALL TRANSACTIONS BETWEEN HERITAGE AND APPLICANT SHALL BE GOVERNED EXCLUSIVELY BY THE FOLLOWING TERMS OF CREDIT. THESE TERMS MAY NOT BE ALTERED BY THE INCLUSION OF CONTRADICTORY LANGUAGE ON APPLICANT'S PURCHASE ORDER.

- 1. PAYMENT IS REQUIRED 30 DAYS FROM THE DATE OF INVOICE. A MONTHLY SERVICE CHARGE OF 1.5% WILL BE ADDED TO ALL AMOUNTS NOT PAID WITHIN 30 DAYS OF THE DATE OF INVOICE.
- 2. IF AN ATTORNEY IS USED TO COLLECT ANY AMOUNT DUE, EITHER WITH OR WITHOUT SUIT, OR IF LEGAL PROCEEDINGS ARE TAKEN FOR THE COLLECTION OF ANY AMOUNT DUE, APPLICANT SHALL PAY, IN ADDITION TO THE PRINCIPAL AND INTEREST OWING, THE COSTS OF SUIT, AND ATTORNEY FEES IN THE AMOUNT OF 20% OF THE AMOUNT DUE INCLUDING INTEREST.
- 3. APPLICANT AGREES THAT ANY DISPUTE, CONTROVERSY, OR CLAIM ARISING IN CONNECTION WITH THE REQUEST-ED CREDIT OR IN CONNECTION WITH ANY GOODS PURCHASED BY APPLICANT, SHALL BE DECIDED EXCLUSIVELY BY AND IN THE STATE OR FEDERAL COURTS SITTING IN NEW CASTLE COUNTY, DELAWARE. FOR SUCH PURPOSE, APPLICANT HEREBY SUBMITS TO THE PERSONAL JURISDICTION OF SAID COURTS, AND WAIVES ANY RIGHT TO ASSERT OR MOVE FOR TRANSFER OF VENUE TO ANY COURT OTHER THAN SAID COURTS. ALL DISPUTES SHALL BE GOVERNED BY AND PURSUANT TO DELAWARE LAW. APPLICANT FURTHER AGREES THAT ANY AND ALL PURCHASE ORDERS SUBMITTED TO HERITAGE BY APPLICANT SHALL BE GOVERNED BY THIS PROVISION, REGARDLESS OF THE INCLUSION OF ANY LANGUAGE TO THE CONTRARY IN SUCH A PURCHASE ORDER, INCLUDING BUT NOT LIMITED TO PROVISIONS CONCERNING ALTERNATE VENUES OR SUBMISSION OF DISPUTES TO ALTERNATIVE DISPUTE RESOLUTION.
- 4. THE APPLICANT AND THE UNDERSIGNED, WHETHER OR NOT SIGNING IN A REPRESENTATIVE CAPACITY, WARRANT THAT THE INFORMATION CONTAINED IN THIS APPLICATION IS TRUE, COMPLETE AND CORRECT, AND THE UNDERSIGNED HAVE BEEN DULY AUTHORIZED TO EXECUTE THIS APPLICATION.
- 5. IT IS FURTHER ACKNOWLEDGED AND UNDERSTOOD THAT THE APPLICANT HAS READ AND UNDERSTANDS THIS APPLICATION. IT IS ALSO UNDERSTOOD THAT NO CREDIT WILL BE EXTENDED TO APPLICANT UNTIL THIS AGREEMENT IS APPROVED BY THE CREDIT MANAGER OF HERITAGE CONCRETE, LLC.
- 6. THIS APPLICATION WILL NOT BE APPROVED WITHOUT THE SIGNATURES OF ALL PARTNERS IF APPLICANT IS A PARTNERSHIP, BOTH HUSBAND AND WIFE IN THE CASE OF A SOLE PROPRIETORSHIP, AND THE PRESIDENT OR VICE PRESIDENT IN THE CASE OF A CORPORATION. I HAVE READ AND AGREE TO THE ABOVE TERMS OF CREDIT.
